DOH, in partnership with the Department of Human Services (DHS), is excited to launch QIP-NJ on July 1, 2021 and to focus on driving statewide quality improvements in maternal and behavioral health (inclusive of both mental health and substance use disorder services services). Additionally, QIP-NJ aligns with and furthers the goals of New Jersey (NJ) State leaders, including the Murphy Administration and the First Lady's Office, through the Nurture NJ initiative and strategic plan, among other key policy frameworks.

Lastly, DOH would also like to welcome and introduce a new member of the DOH team – Erica Bonnifield, who will serve as the state lead for QIP-NJ. Erica joins us after working for approximately six years at the California Department of Health Care Services, as part of the team responsible for setting benefits and eligibility policy for California's Medicaid program (Medi-

Cal). Erica is excited to provide support to New Jersey hospitals participating in QIP-NJ as they work towards achieving stated performance targets and looks forward to working with other key partners and stakeholders to make QIP-NJ successful.

CMS QIP-NJ Approval

DOH is awaiting approval of QIP-NJ from the federal Centers for Medicare & Medicaid Services (CMS). DOH submitted QIP-NJ via a Section 438.6(c) Preprint for a one-year approval and has been actively working with CMS to obtain approval. Please note that QIP-NJ is envisioned as a five-year initiative, and DOH is actively working with CMS to secure a subsequent multiyear approval. DOH will provide updates on the status of QIP-NJ approvals in future communications.

QIP-NJ Measure Specifications & Submission Guidelines: Available Soon!

The Measurement Year 1 (MY1) QIP-NJ Measure Specifications & Submission Guidelines (also known as the Databook) will be posted to the QIP-NJ Resources webpage in early May 2021. The Databook will provide the submission guidelines and specifications for the QIP-NJ performance measure set in MY1. Please note the measure specifications will be reviewed and updated as needed each measurement year.

In addition to the QIP-NJ Measure Specifications & Submission Guidelines, the Value Set Compendium (VSC) and Q&A document will also be available upon CMS approval. The VSC will contain all the value and code sets (e.g. Current Procedural Terminology (CPT), Healthcare Common Procedure Coding System (HCPCS)) referenced in the Databook and the Q&A document will answer questions DOH has received regarding the measure specifications since posting the draft version of the Databook back in November 2020. QIP-NJ MY1 "Letter of Intent" Materials

As announced during the QIP-NJ Introductory Webinar, DOH is implementing a "Letter of Intent" process, which requires all NJ acute care hospitals to actively respond indicating whether or not they intend to participate in QIP-NJ MY1. In confirming or declining participation, hospitals will acknowledge and agree to set of conditions listed in the Letter of Intent materials. The Letter of Intent must be completed by an approved hospital representative and signed by the hospital Chief Executive Officer (CEO), Chief Financial Officer (CFO), Chief Medical Officer (CMO), or Chief Quality Officer (CQO). While the QIP-NJ Letter of Intent is a formal indication to DOH of a hospital's intention whether or not to participate in QIP-NJ, it is not a legally binding document.

The QIP-NJ MY1 Letter of Intent materials will be posted to the QIP-NJ Participants webpage in early May. All NJ hospitals will be informed of the availability of these materials and are expected to complete and submit the signed QIP-NJ MY1 Letter of Intent to DOH by Tuesday, June 15, 2021.
