#### **DOH Corner**

As mentioned above, QIP-NJ officially went live on July 1, 2021! DOH is extremely excited to report that 62 hospitals are participating in QIP-NJ for MY1, either in the maternal health component (3), behavioral health (BH) component (18) or both (41). For those participating hospitals, DOH looks forward to working in close partnership with your hospital teams to improve care for the maternal health and BH populations in NJ.

In addition, DOH is also hosting a voluntary BH Learning Collaborative (Collaborative) starting in the fall of 2021, which will function to foster and support the success of hospitals participating in QIP-NJ through close collaboration with Collaborative faculty and subject-matter experts in maternal health and BH, shared learning models, and advancement of evidence-based best practices to help improve outcomes and ultimately make QIP-NJ

successful. DOH is very encouraged to report that as of the date of this publication, 50 hospitals have formally committed to joining the Collaborative. For more information about how to join, please see the Collaborative Participation Interest Form final reminder below.

Lastly, DOH would just like to again thank hospitals for their continued engagement and feedback relative to various QIP-NJ webinars, forums, and meetings. ### Reminder: Databook, VSC, and Databook FAQ v1.1 Available Online

On July 1, 2021, the next iteration of the Databook and VSC (v1.1), as well as the Databook FAQ were posted to the QIP-NJ <u>Documents & Resources</u> webpage. A change log was also included in the Databook v1.1 to show and describe all changes made from Databook and VSC v1.0 to v1.1. ### Now Available: Baseline (MY0) Attribution Rosters

DOH is pleased to announce that the baseline attribution rosters for QIP-NJ, including both the behavioral health (BH) and maternal health components, have been posted to the QIP-NJ Secure File Transfer Protocol (SFTP). The three, previously identified SFTP users per hospital should have received credentials for the QIP-NJ SFTP from QIP-NJ@pcqus.com. Instructions for logging in and using the SFTP are available in the QIP-NJ SFTP User Guide, posted on the QIP-NJ Participants & Stakeholders webpage.

DOH strongly encourages all hospitals to review their attribution rosters for completeness and accuracy in a timely manner in advance of the baseline non-claims-based performance measure submission, which runs from Monday, August 2, 2021, through Thursday, September 30, 2021.

As a reminder, details on the attribution methodology may be found in the Databook v1.1 section "Attribution Methodology Overview" (pp. 14-15).

If hospitals believe there are potential patient-level discrepancies in their attribution roster(s), they should fill out the "Attribution Feedback Form" sent to hospitals on Monday, July 26<sup>th</sup>. This form will require submission of the tab "Hospital Tracking" with hospital information as well as overall specifics regarding the issue. Tab "Individual Tracking" will allow the hospital to provide the minimum-necessary individual data elements found within the attribution roster to allow DOH to investigate the issue further, and, if needed, undertake any appropriate follow-up action to remediate. The "Attribution Feedback Form" has been uploaded to each hospital's "Inbound" folder on the QIP-NJ SFTP. If hospitals intend to complete this form, it must be submitted to your hospital's "Outbound" folder on the QIP-NJ SFTP by 5:00 PM EST on Friday, August 13, 2021.

Thank you to all the hospitals who have participated in the first two technical contact forums. DOH will be hosting the third QIP-NJ Hospital Technical Contact Forum on <u>Wednesday</u>, <u>August 4</u>, <u>2021 from 11:00 AM to 12:00 PM EST</u> to review the baseline attribution rosters and the data entry process for non-claims-based data into the Standard Reporting Template.
