DOH Corner

QIP-NJ is now approximately nine months into MY 3, which began in January 2023 and will run through the end of the year. DOH continues to appreciate all the time, effort, and resources that participating hospitals are putting into QIP-NJ and looks forward to seeing continued quality improvement for both the maternal health and behavioral health (BH) populations.

As you are likely already aware, claims-based results and PLRs were made available to MY 2 participating hospitals last month via the Secure File Transfer Protocol (SFTP). The appeals period of claims-based results closed on September 12th. The QIP-NJ team is currently reviewing and adjudicating timely appeals received from participating hospitals relating to MY 2 results.

This month, DOH convened the QMC for meeting #10, which was intended to gather feedback on the measurement strategy for MY 4 and beyond. As QIP-NJ nears its final MYs, DOH anticipates fewer changes to the measurement strategy to decrease the effort required to report data, consistency across MYs, and ensuring continued compliance with federal Centers for Medicare and Medicaid Services (CMS) requirements.

Important: Measurement Year (MY) 2 Non-Claims Based Results to be Released

The Department is in the process of reviewing MY2 NCB measure performance for QIP-NJ. Results will be made available early next month in each hospital's MY2 folder, in the DOH Materials folder in the QIP-NJ Secure File Transfer Portal (SFTP). Along with the release of NCB results, QIP-NJ will publish NCB appeals guidance to the Participants & Stakeholders page of the QIP-NJ website. Upon submission of NCB appeals, please email the QIP-NJ@pcgus.com following your submission to confirm receipt of the files.

As a reminder, only reporting and computational errors may be appealed in QIP-NJ. Disputes related to CMS and DOH-approved QIP-NJ protocols, including, but not limited to, program policy, formula designs, or statewide targets, are not appealable and such requests will not be reviewed.

MY2 Claims-Based Measure Appeals Under Review

The claims-based measure appeals process began on August 28, 2023, and ended on September 12, 2023. Each hospital received measure results and Patient Level Reports (PLRs) for all claims-based measures. DOH is now actively reviewing claims-based measure appeals and hospitals will be notified of results in mid-October.

Quality Measures Committee (QMC) #10 Meeting

DOH, in partnership with PCG, convened the QMC for meeting #10 on Thursday, September 28, 2023. During the meeting, DOH and PCG provided programmatic updates, gathered targeted feedback on updates, and addressed clarifying questions about the QIP-NJ measure portfolio. Specifically, the agenda included, but was not limited to, the following:

- Reviewing overall goals of QIP-NJ and associated timelines.
- Sharing program updates, including measure updates based on the full evaluation of MY 1:
- Reviewing requests and clarifying questions about measure compliance and possible adjustments for MY 4; and

 Discussing next steps for the QMC and expected communications in preparation for updates to the MY 4 Databook and Standard Reporting Template guidance.

- DOH recently announced that it will be hosting an all-hospital webinar on November 6, 2023 at 12:00 PM EST, which will be hosted via Microsoft Teams and require registration. The webinar will provide hospitals with information about DOH's recent work in the hospital financial reporting and transparency space, which includes creation of a new, annual compilation report that utilizes financial data from annual, audited Acute Care Hospital Cost Report submissions. All hospital Chief Executive Officers and Chief Financial Officers received a "Save-the-Date" invitation to register for the event.
